# **Wificoin Privacy Policy**

At Wificoin, your privacy is a top priority. Wificoin Inc. (hereinafter "Wificoin," "we," "our," or "us") is committed to safeguarding and handling your Personal Information in a responsible and secure manner.

This Privacy Policy describes how we process your Personal Information as you use our website located at www.wificoin.co (the "Services"). Personal information is data that can be used to identify you directly or indirectly, or to contact you.

## **Acceptance of Privacy Policy**

By accessing and using our Services, you signify acceptance to the terms of this Privacy Policy and consent to the collection, use, and disclosure of your personal information as described below. If you do not agree with or you are not comfortable with any aspect of this Privacy Policy, you should immediately discontinue access or use of our Services.

## **Changes to this Privacy Policy**

We may modify this Privacy Policy at any time without prior notice to you, and changes may apply to any Personal Information we already hold about you and any new Personal Information collected after the Policy is modified. If we make changes, we will notify you by revising the Last Updated date at the top of this Privacy Policy. If you continue to use our Services after receiving the notice of changes, you acknowledge that you consent to the updated Privacy Policy. We will provide you with advanced notice if we make any material changes by posting a new notice or by sending you an email.

#### Information You Provide to Us

In connection with the Services, we may ask you to provide these categories of Personal Information ("Personal Information"):

- Account Information: Information you provide about yourself to access our Services, including name, email, phone number, address and password.
- Payment Information: When you make an order through our Services, you will need to provide us with a credit card for payment, including billing information.
- Voluntary Information: Information you provide to us voluntarily by completing web forms, participating in surveys, polls, blogs, postings and other mediums constitutes Voluntary Information.

# Information We Collect Through Your Use of the Services

When you use the Services, we automatically collect information about how you use them ("Passive Information") as described below:

- Usage Information: We collect information about your interactions with the Services, such as the pages you view and other actions you perform while using the Services.
- Log Data: We automatically collect log information when you use the Services. For example, your IP address, access times, hardware and software information, device information, device event information (e.g., crashes, unsuccessful logins, browser type), the page you've viewed or engaged with before or after using the Services, and other relevant information.
- Location Information: We may collect your location information when you visit our sites or use our applications, including location information either provided by a mobile device, or associated with your IP address.
- Cookies and Similar Tracking Technologies: We may use various tracking technologies (e.g., cookies, beacons and pixels) to collect and store information about your use of our Services. We use these tools to ensure that you receive a personalized experience, and to keep your account safe. Please refer to the "Cookies" section below for more information.

#### How We Use and Disclose Your Personal Information

We may use your Personal Information and passive information for various purposes, including:

- Providing, analyzing, and improving the Services.
- Communicating with you regarding our Services, and promotions.
- Working with third parties. We may use third parties to perform certain services on our behalf in connection with the Services such as:
  - o to process and store data, including your Personal Information;
  - o to help us better advertise our Services; and
  - o to help ensure that your Personal Information is secure.

Unless we inform you differently, the third parties we work with do not have permission to use the information we share with them beyond what is necessary to assist us. We execute agreements with third parties to ensure they use adequate safeguards when processing your Personal Information in accordance with this Policy.

- Complying with our legal obligations. We may share your Personal Information if it is reasonably necessary to:
  - Comply with a valid legal process (e.g., subpoenas, warrants, court orders, etc.);
  - Comply with requests or investigations by public authorities;
  - Comply with applicable laws or regulations;

- Enforce or apply the Wificoin policies or policies of our partners;
- o Protect the security or integrity of the Services; or
- Protect the rights, property or safety of Wificoin, our employees or users, partners and affiliates, or other natural persons.

We will, at our discretion, provide you with advance notice if we are compelled to disclose your Personal Information to law enforcement, unless we are prohibited from doing so by public authorities or the law.

- Merger, Bankruptcy or Corporate Reorganization. We reserve the right to disclose and transfer your Personal Information:
  - o To a subsequent owner, co-owner or operator of Wificoin or the Services; or
  - In connection with a merger, consolidation, restructuring, the sale of substantially all of our interests and/or assets (i.e., a bankruptcy proceeding), or other corporate change.

By using our Services you agree to and consent to assignment or transfer of our rights to your Personal Information as described above.

#### Cookies

As mentioned above, Wificoin uses cookies and similar tracking technologies to collect information about your use of our Services and to provide you with functionality on our Services. Cookies are small files, typically of letters and numbers, downloaded onto your computer or mobile device when you visit certain websites.

Generally, we use first-party and third-party cookies for the following purposes:

- To make our Services function properly;
- To provide a secure browsing experience during your use of our Services;
- To collect passive information about your use of our Services to help us improve our Services: and
- To remember your preferences for your convenience.

We use the following types of cookies on our Services:

- Strictly Necessary Cookies. These cookies are essential because they enable you to move around and use our Services. For example, strictly necessary cookies allow you to access secure areas on our Services. Without these cookies, some services cannot be provided. These cookies do not gather information about you for marketing purposes. This category of cookies is essential for our Services to work and they cannot be disabled.
- Functional Cookies. We use functional cookies to remember your choices so we can tailor our Services to provide you with enhanced features and personalized content. For example, these cookies can be used to remember your name or preferences on our Services. We do not use functional cookies to target you with online marketing. While these cookies can be disabled, this may result in less functionality during your use of our Services.

- Performance or Analytic Cookies. These cookies collect anonymous passive information about how you use our Services, including webpages you visit, and links you click. We use the information collected by such cookies to improve and optimize our Services. We do not use these cookies to target you with online marketing. You can disable these cookies.
- Advertising Cookies. These cookies are used to deliver advertisements based on your interests and preferences. They collection passive information about you to help measure the effectiveness of an advertising campaign. They remember when you have visited a website and such information may be shared with advertisers or other organizations. For example, after visiting our Services, you may see advertisements about our Services elsewhere on the Internet. You can disable these cookies as described below under "How to Manage Cookies."
- Third-Party Cookies. These are cookies that are provided by a third-party service provider and belong in one of the cookie categories described above. We may use third-party cookies on our Services, but we do not control what information is collected by third-party cookies nor how it is used. If you would like more information on how a certain third party uses cookie information, please visit their website to find out.

Depending on whether you would like to manage a first-party or third-party cookie, you will need to take the following steps:

- First-Party (or Wificoin's) Cookies: You can enable, disable or delete cookies through the browser you are using to access our Services. To do this, follow the instructions provided by your browser (usually located within the "Help", "Tools" or "Edit" settings). Please note, if you set your browser to disable cookies, you may not be able to access secure areas of our Services, and/or parts of the Services may not work properly for you. - Third-Party Cookies: You can disable cookies from participating advertising companies
  or only advertising provided by specific advertising companies. For more information

### **Your Choices**

- Voluntary Information: You may choose not to provide your Personal Information. However, if you do not provide us with some of your Personal Information, such as your name or email, we may not be able to provide you with access to our Services.
- Modify Your Account Information: You may access your account and update your Personal Information. When you update your account information, we may keep a copy of your previous account details for our record.
- Communication Preferences: If you do not want to receive emails from us, please adjust your communication preferences or click the unsubscribe link within the email you received from us.
